7. A request for packing services from Grainpac Pty Ltd by the Applicant at any time shall constitute a warranty that the applicant is solvent at that time.
8. Pursuant to the Privacy Act 1988 (as amended), Grainpac Pty Ltd may obtain from a credit-reporting agency a report containing personal credit information about the Applicant in relation to credit provided by Grainpac Pty Ltd. I / we agree that Grainpac Pty Ltd may exchange information about me / us with those trade credit providers named in the Application for Credit or named in a consumer credit report issued by a credit-reporting agency for the following purposes: to assess the credit worthiness of the Applicant; to notify other credit providers of a default by the Applicant; to exchange information with other credit providers as to the status of this credit account; and where the Applicant is in default with other credit providers.
